### **International Conference Lex Sportiva at UPH**

Lippo Village, 22nd September 2010 - Faculty of Law, Universitas Pelita Harapan, in cooperation with Indonesia Lex Sportiva Instituta, organized an International Conference Lex Sportiva (Sports Law), today, at the FMU campus. This conference is relevant and important for the government of the Republic of Indonesia after the birth of UU No. 3, 2005 on National Sports System and three implementing regulations, as well as to commemorate the National Sports Day which falls on September 9, 2010, and before the implementation of the SEA Games 2011 in Palembang.

In order to answer various questions about the existence of Lex Sportiva and its relationship with the legal system of a country or internationally, this seminar will present nine experts of international sports law and some legal experts and sports experts from Indonesia to discuss and talk about Law and Sports, to be precise about the system transnational law then popularly called Lex Sportiva terms that entered the globalization. Organisers hope the speakers who come from different countries and sports organizations can provide useful information as input to the development of sports law enforcement in Indonesia is still not there.

Given the importance of this conference, the Minister of Youth and Sports, Dr. Andi Alfian Mallarangeng and KONI chairman, Dr. (Hon) Rita Subowo, expressed his willingness to be the keynote speaker. This opportunity to socialize as well as the importance of transnational sports law (Lex Sportiva) applied in Indonesia. With the implementation of this Lex Sportiva, the standard sports law of our country will be equal to the applicable international and is expected to provide easy and clear rules. Lack of sports law in force, as often happens in the world of sports in Indonesia during this time, of course, would be detrimental to the organization / institution and the athlete himself.

At the end of this seminar is a signatory to the declaration of the importance of the role of lawyers and legal expert's sports or academics, to jointly develop Lex Sportiva worldwide. The declaration signed by the representatives of various countries including:

According Hinca, the organization of this seminar is often motivated debate about "law and sport". "Talk about the law and exercise, of course, come into contact with other aspects such as the legal system of a country, the international legal system, as well as transnational legal system. In this seminar will discuss what criteria and benchmarks sports law, as well as at the boundaries where Lex Sportiva can reach the legal issues that arise from the exercise, in a country and at the international level," he explained.

The conference is due to be held in The Den Haag, but moved to Indonesia, precisely on the campus of the University of Pelita Harapan. UPH's displacement due to this activity because Faculty of Law UPH willingness to support these activities. This activity is in line with the vision and mission of the Holistic Education implemented at UPH that not only prioritizes knowledge, but also relies on a balance between knowledge of the sport and the arts.
